

Underwriters

The following is a list of underwriters covering CAA's various insurance products.

Auto Insurance

Auto Insurance is underwritten by CAA Insurance Company (except in Alberta, British Columbia and Quebec). BCAA Optional Car Insurance and Autoplan are sold through B.C.A.A. Holdings Ltd. dba BCAA Insurance Agency, a licensed insurance agency. BCAA Optional Car Insurance is underwritten by CAA Insurance Company and Autoplan is underwritten by the Insurance Corporation of British Columbia.

In Alberta, auto insurance is sold by AMA Insurance. Auto insurance sold by AMA Insurance is largely underwritten by Alberta Motor Association Insurance Company (some exceptions apply).

CAA Tire coverage is underwritten by CAA Insurance Company (except in Alberta, British Columbia and Quebec). Tire coverage is not offered in Alberta.

Home Insurance

Property Insurance is underwritten by CAA Insurance Company (except in Alberta, British Columbia and Quebec). Property Insurance is sold through B.C.A.A. Holdings Ltd. dba BCAA Insurance Agency, a licensed insurance agency, and underwritten by BCAA Insurance Corporation. In Alberta, property insurance is sold by AMA Insurance. Property insurance sold by AMA Insurance is largely underwritten by Alberta Motor Association Insurance Company (some exceptions apply).

CAA Legal Coverage and CAA Legal Plus Coverage is underwritten by CAA Insurance Company. Claims administered by ARAG Legal Solutions Inc. (ARAG). CAA Legal Coverage is not offered in Alberta.

Emergency Travel Medical Insurance is underwritten by CAA Insurance Company. Claims are administered by Global Excel Management. This is not offered in Alberta.

Travel Insurance

CAA Travel Insurance is underwritten by Orion Travel Insurance Company, a CAA Company (except in British Columbia and Quebec). BCAA Travel Insurance is sold through B.C.A.A. Holdings Ltd. dba BCAA Insurance Agency, a licensed insurance agent and is underwritten by BCAA Insurance Corporation. Insurance claims are administered by Orion Travel Insurance Company and its subcontractors, Global Excel Management Inc.
